

For decades, California American Water (CalAm) has been overdrafting the Carmel River, impacting the river's health, surrounding ecosystem, and wildlife. To protect the river for future generations, a Cease and Desist Order (CDO) was enacted on December 31, 2021. The CDO will remain in place until the State Water Resources Control Board agrees to lift it. For the 2021-2022 water year, CalAm has legal rights to pull 4,110 acre-feet. The year after, it will shrink to 3,376 acre-feet of water.

CARMEL RIVER WATERSHED PREPARES FOR WILDFIRE SEASON

We have already seen an early start to fire season throughout California due to ongoing drought and historically low rainfall. Recent data shows January, February, and March were the driest first three months of the year in California

history. These conditions have prompted CAL FIRE to suspend all burn permits in Monterey and Santa Cruz counties. It is imperative to take the necessary precautions to protect ourselves and others from the threat of wildfire.

2021-2022 WATERSHED EDUCATION PROGRAM

CRWC directed another successful Watershed Education Program during the 2021-2022 school year, with 27 in person field trips and 9 virtual sessions. Facilitated in partnership with the Santa Lucia Conservancy, the program hosted a total 867 visitors, of which 665 were schoolchildren. The Watershed Education Program served groups from all over the Monterey region, including Carmel and Salinas.
